

- More than two years of full-time teaching experience
- Credential evaluation from an approved U.S. agency
- Degree must be from an accredited university
- Advanced proficiency in oral and written English

## Requirements for schools


All **accredited** public and private U.S. primary and secondary schools (K-12) are eligible to host exchange visitor teachers.

- Must start at the **beginning of the academic year**.
- collective bargaining agreement.
- those of similarly-situated U.S. teachers.

• Teaching positions must be **full-time** (min. 32 hours per week) of teaching or teaching-related administrative activities.

• Exchange Visitor Teachers **comply with any applicable** 

• Teaching positions, including duties, responsibilities, hours of employment, and compensation, are **commensurate with**


